

## **RESEARCH MANAGER – MEAL**

The Research Manager will be responsible for managing research projects, partners, and research agencies, in addition to contributing to various aspects of work under Monitoring and Evaluation (M&E) and advocacy.

## A. KEY RESPONSIBILITIES

#### Management Skills

- Partnership management, including managing relationships with research partners and vendors. The ideal candidate will be expected to manage research projects end-to-end
- Project management ability to manage multiple research projects simultaneously. The ideal candidate will have excellent project management skills. Relevant project management experience is desirable, but not mandatory
- Manage/oversee funder-driven evaluations (baselines and endlines) and other studies such as needs assessments, scoping studies, landscape analyses and others, based on organisational needs

## Technical Skills

- Draw insights through data analysis and regular field visits/programme feedback mechanisms to improve the efficacy of existing Apnalaya programmes
- Knowledge of data analysis tools such as SPSS/STATA/R is desirable, but not mandatory
- Develop frameworks and lead the creation and delivery of effective training

materials and other related measurement tools that sharpen programme delivery and improve quality

- Work with teams across the organisation to develop and advance our Theory of Change
- Develop and implement log frames for programme delivery, with a clear focus on outcomes

# Advocacy and Communications

- Identify and develop collaborative partnerships with governments, civil society and communities, with a view towards influencing lasting and sustainable change
- Plan, design and implement advocacy communication and activities
- Support the Director in other advocacy-related tasks, based on organisational needs

- A background in social sciences/ social work/statistics is preferred, but not mandatory
- 2-3 years of relevant experience

- A keen eye for detail and high levels of ownership
